Exciting News! Yavapai County Elections is now offering the option for candidates running for county offices in 2024 to collect nomination petition signatures through the Secretary of State's E-Qual system.

Follow these easy steps to set-up an account:

### STEP 1:


Visit <https://apps.azsos.gov/apps/election/eps/Portal> to create a candidate account.

RUNNING FOR LOCAL OFFICE IN ARIZONA?

Candidates running for county, city, and town office in Arizona may collect 100% of their required nomination petition signatures through the E-Qual system. E-Qual enables eligible voters to electronically sign these petitions. Arizona Online Petition Portal allows candidates to create and manage their online nomination petitions for elections by participating jurisdictions.

I, the undersigned, a qualified elector of the county of Yavapai, state of Arizona, and of Yavapai County and a member of the Republican party or a person who is registered as no party preference or independent as the party preference or who is registered with a political party that is not qualified for representation on the ballot, hereby nominate sally Jo who resides at 123 Main Prescott AZ 86305 in the county of Yavapai for the party nomination for the office of County Recorder to be voted at the primary election to be held August 6, 2024 as representing the principles of such party, and I hereby declare that I am qualified to vote for this office and that I have not signed, and will not sign, any nomination petition for more persons than the number of candidates necessary to fill such office at the next ensuing election. I further declare that if I choose to use a post office box address on this petition, my residence address has not changed since I last reported it to the county recorder for purposes of updating my voter registration file.
